## Nature Connect Liability and Release

**This document affects your legal rights – Read It Carefully.**

Nature Connect, Church of the Apostles, Inc. (COTA), South Alabama Land Trust (SALT), Weeks Bay Plantation (WBP) Elizabeth Brinkley Hutchings, and all Nature Connect staff and volunteers are committed to conducting outdoor programs and activities in a safe manner. As program staff, we attempt to reduce risks and insist that all program participants and visitors follow program safety rules and instructions.

I, parent/legal guardian, hereby agree to indemnify and hold harmless Nature Connect, COTA, SALT, WBP, and all Nature Connect volunteers and staff, from and against any and all liability for any injury or death which may be suffered by me or my child arising out of or in any way connected with participation in the program(s) named here. I understand that there is a risk of serious injury or bodily harm when participating in any outdoor recreational activity. Not all hazards and dangers can be foreseen. These risks include, but are not limited to, poisonous snakes, wildlife, dogs, poisonous plants, poisonous trees, poisonous berries, poison ivy, bees, ticks, mosquitoes, wasps, red velvet ants, uneven paths and trails, holes from fallen trees, falling branches, roots, sticks, tree branches, ditches, creek bed, and water. Further risks include, but are not limited to, slipping, falling, drowning, poor health conditioning of participants, carelessness, horseplay, and the like on the part of participants. I recognize and acknowledge that it is impossible for the staff of Nature Connect to guarantee absolute safety, and I desire for my child to participate in Nature Connect, being fully aware there are such risks.

In consideration of the opportunity for my child to participate in Nature Connect, I hereby release Nature Connect, COTA, WBP, and SALT from any liability for any injury suffered by me or my child in connection with our participation in Nature Connect. I, the undersigned participant, hereby agree that by signing this document, I expressly assume any and all risk and legal liability and waive, discharge, and release any and all claims of liability, foreseeable and unforeseeable, even if caused by negligence, against COTA, SALT, WBP, and all Nature Connect staff and volunteers including Elizabeth Brinkley Hutchings, for injuries (including death), damages, or loss which I, my minor child, members of my group, or our agents, might sustain as a result of participating in any and all activities connected with or associated with Nature Connect Programs. As liquidated damages, I hereby agree that if Nature Connect staff, COTA, WBP, or SALT, are forced to defend any action, lawsuit, or litigation by myself, my executors, my heirs, successors, or assigns, that I agree to pay to Nature Connect, COTA, WBP and SALT the full costs and attorney's fees if they successfully defend such action, lawsuit, or litigation.
